

存款指南 Deposit Guide

銀行轉帳或匯款存入:

閣下可透過銀行的櫃檯服務、自動櫃員機、網上銀行或電話理財服務,存款到國 元証券經紀(香港)有限公司或國元期貨(香港)有限公司的指定銀行帳戶或本司為 閣下開立的工銀亞洲或渣打銀行子帳戶。

Bank Transfer or Remittance:

Customer can deposit into the designated bank account of Guoyuan Securities Brokerage (HK) Ltd or Guoyuan Futures (Hong Kong) Limited or the sub-account of ICBC (Asia) or Standard Chartered Bank through the bank's counter service, ATM, online banking or phone banking service.

款項存入後,客戶需要當天不遲於下午四點前把存款證明文件電郵至 cs@gyzq.com.hk或傳真至本司 ((852) 3769 6981 / (86) 755 2151 6070) 以便查帳。一般情況下,得到銀行確認後,有關款項將盡快存入客戶的帳戶內。

After deposit is made, please email deposit proof to cs@gyzq.com.hk or fax to (852) 3769 6981 / (86) 755 2151 6070 before 4:00 p.m. Normally, the relevant funds will be credited into customer's Guoyuan trading account after confirmation from the bank.

支票存款:

客戶亦可選擇以支票方式存入款項,並把存款證明及支票複印本電郵至 cs@gyzq.com.hk或傳真至本司 ((852) 3769 6981 / (86) 755 2151 6070) 以便查帳。一般情況下,我司會在入帳後第二個工作天約下午四時後經銀行確認已過戶,才會將該筆款項存入客戶帳戶內。

Cheque Deposit:

Customer also can make deposit by cheque, then email deposit proof and cheque copy to cs@gyzq.com.hk or fax to (852) 3769 6981 / (86) 755 2151 6070 before 4:00 p.m. Normally, the relevant funds will be credited into customer's Guoyuan trading account after confirmation from the bank on the next working day around 4:00 p.m.
